Motion was made and passed to go to the training part of the program. Chief Robert Duval of the N.F.P.A. gave a presentation from Home Fire Sprinkler Coalition has released 3-D videos of full room fires with and without sprinklers as part of their rollout of VR training. residential sprinklers.

Flyer for the CT Fire officer's weekend was available. In March the academy is hosting boot camp. There was a decrease to the actual budget. The foam take back program is finishing up for container pick up. Three foam trailers have been cleaned. If a foam trailer is needed and has not been cleaned the current foam may be used with permission.

Legislative Committee- John Carew gave a report on legislation. There were several public hearings held online but there were some technical difficulties with the feed. The fire marshals were opposed to changes in the fireworks bill though two legislative representatives were speaking in favor.

Flanagan Fund- Peter Beckwith advised there has only been two applications received. We need to get the word out about this scholarship to all departments.

Technical Advisory Committee was reported on by Chief Duval they have had two meetings since the last time we met. They now have a process in place, and they will have an email address and an office thanks to the academy. There was discussion on funding and how that would be administered.

Tim Wall reported that the March Meeting will be held in New Haven County.

Ed Urbanski reported on the Memorial there will be changes made in the next couple of months.
